

# Te Kōhanga Reo o Ngā Kuaka (Ngā Kuaka)

## Kaupapa Here Rongoā Ārainga Mate

### Immunisation Policy

#### 1. Te Pūtake:

Te Whāriki: Hauora: Ka whakanuia e tātou te hauora o ā tātou tamariki  
E ai ki ngā *Rekureihana Hauora (Rongoā Ārai Mate) 1995*, me noho tika ngā rīkoata Rongoā Ārainga Mate mō ngā tamariki katoa kei raro i te maru o Te Kōhanga Reo o Ngā Kuaka.

- 1.1 Ki tā te Te Kōhanga Reo o Ngā Kuaka kei ngā mātua te mana ki te whakatau me he pai te Rongoā Ārainga Mate, kāore rānei mō t/ā rātou ake tamariki/tamaiti.
- 1.2 Kei te Kōhanga me tō tākuta ētehi atu kōrero mō ngā āhuatanga pai me ngā āhuatanga tūpono o te Rongoā Ārainga Mate nā reira, mehemea he pātai, he māharahara rānei ōu, tēnā haere ki tō tākuta, ki te tari o te Kōhanga rānei pātai ai.
- 1.3 Mā Te Kōhanga Reo o Ngā Kuaka e whakahōungia tā mātou rēhita Rongoā Ārainga Mate
  - a. Ina whakauru mai tētehi tamaiti hōu me whakaatu mai tāna Tīwhikete Rongoā Ārainga Mate ki te Kōhanga, ā, mā mātou e whakarārangihia ki tā mātou rēhita.
  - b. Mehemea kua whiriwhiria e koe kia kore whāngai ai tāu tamaiti ki te Rongoā Ārainga Mate, mā mātou tēnā e tuhituhi ki tā mātou Rēhita Rongoā Ārainga Mate me te Puka Whakauru o tāu tamaiti.
  - c. Me whakamōhio mai ki te/ngā Kaiwhakahaere mehemea ka whāngaihia anōtia tāu tamaiti ki te Rongoā Ārainga Mate i a ia i raro i te maru o te Kōhanga Reo o Ngā Kuaka
  - d. Ki te ara ake tētehi take, mā ngā Kaiako me ngā Āpiha o te Manatū Hauora anakē hei pānui i aua rīkoata muna
- 1.4 Ki te pā mai tētehi mate urutā o te Rārangi Ārainga Mate ā-Motu ki tāu tamaiti, ā, kua whakaaetia e te tākuta ko tērā te mate o tāu tamaiti, mā Te Kōhanga Reo o ngā Kuaka e pānui atu ki ngā whānau me te Nēhi Hauora Iwi Whānui o te Poari Hauora o Waikato.
- 1.5 Ki te pā tūpono mai tētehi mate urutā o te Rārangi Ārainga Mate ā-Motu, mā te Āpiha Hauora te kōhanga e Arahi.

## 1. Rationale:

Te Whāriki: Well-being: Children experience an environment where their health is promoted.  
*The Health (Immunisation) Regulations 1995* require Te Kōhanga Reo o Ngā Kuaka to keep accurate immunisation records of all tamariki enrolled

- 1.1 Ngā Kuaka supports parental choice regarding the immunisation of their tamariki.
- 1.2 Full information regarding the benefits and risks of immunisation is available to parents at Kōhanga and from their GP to enable their informed choice.
- 1.3 Ngā Kuaka will keep an updated immunisation register.
  - a. On enrolment of new tamariki, an Immunisation Certificate must be sighted and added to the register.
  - b. Tamariki whose parents have chosen not to immunise will have this noted on the Immunisation Register and their Enrolment Form
  - c. Parents must advise Kaiwhakahaere of any subsequent immunisations their children have whilst enrolled at Ngā Kuaka.
  - d. These records are confidential to Kaiako and Ministry of Health Officials should the occasion arise for Ministry of Health to sight the register.
- 1.4 In the event of any person contracting a contagious disease named in the Immunisation Schedule and diagnosis is confirmed by a medical practitioner, Ngā Kuaka will notify all whānau and the Waikato District Health Board Public Health Nurse.
- 1.5 In the case of an outbreak of any disease named in the Immunisation Schedule Ngā Kuaka will be guided by the Medical Officer of Health assigned to our case.
